## Michigan Angus Association Board of Directors Meeting September 12, 2013 at the MSU Judging Pavilion, East Lansing, Michigan

President Merle Boehmer called the meeting to order at 7:07 p.m. The agenda was approved as printed.

Minutes: Monte Bordner moved to approve the minutes from the June 8, 2013 meeting. Motion seconded by Dan Vaassen and passed.

Discussion on whether there are other sales we should be sending or taking literature to. Julie French will take care of Clare; Monte Bordner and Kevin Beckington will do Gaylord; Monte and Bob will do Battle Creek; and Chuck Preston will do West Branch. Bob will order free sale kits from the American Angus Association. Pass along any other contacts to Bob. 100 of the black calving books with the Michigan Angus Association logo on it have been ordered.

<u>Directory</u> – Directories will again be available after the meeting.

<u>Fall Sale</u> – 60 lots have been consigned and cattle can be brought in on September 29<sup>th</sup>. Catalogs will go out in a few days. In past years Omega Farms has picked up all the clipping and animal preparation costs – many thanks to Clifford for his generosity. The steak dinner will be held on Friday night. The Sterzick donated heifer will be displayed in a special pen and will be brought into the show barn on Friday night. Nancy Thelen will contact the juniors regarding having them do outreach and membership recruitment at the Fall Sale. An email flyer or reminder will be sent to the members. Discussion regarding more advertising for our sales. We need to advertise for about three weeks in a row in the major weekly publications. Need to include contact information for someone who can take phone calls. At the sale all board members need a name tag and need to meet new people. Janel Horrocks-Boehmer will make the name tags. Janel is also doing the meal and will be contacting the consignors for assistance.

## Old Business:

- Saddle and Sirloin Club Portrait – Julie French and Ken Geuns reported that the fundraising was going well. The on-line auction will be held September 19-24 and the association will help promote it. MSU will be receiving a copy of Dr. Hawkins' portrait to be hung in Anthony Hall. It was suggested that the Michigan Angus Association host a reception for the portrait unveiling. Could tie in with the Winter Beef Classic and possibly hold it at the pavilion on the Sunday afternoon of the winter beef show. Could be like a meet and greet or open house with punch and cake. Could ask other beef organizations to co-host it with us. Dan Vaassen moved to host/co-host with other associations a reception for Dr. Hawkins and the portrait unveiling, and to allocate up to \$1,000 from MAA. Steve Thelen seconded and motion passed.

- Rebecca VanDenBerg has offered to redesign the Angus breeder ads in the MCA magazine beginning with the first issue in 2014. Ed Dawson moved to have Rebecca and Nancy Thelen revamp the ads and keep the ad cost at \$75 for the year. Motion seconded by Dan Vaassen and passed.
- Michigan's delegates to the AAA annual meeting in Louisville are Scott Foster, Dave Lutchka and Monte Bordner. Alternates are Ken Geuns, Julie French and Bob Zellmer.
